# **Open Team Captain's Report** Roy Nixon

The ACT Open Team in 2004 comprised: Margaret Bourke Arjuna De Livera Ian Thomson Richard Brightling David Hoffman David Wawn Roy Nixon (NPC)

As you will all know by now, the ACT Open Team won the "Herald Cup" for only the third time in the history of competition: our previous wins had been in 1981 and 1984.

#### Before the Event

While the team did not want <u>formal</u> practice sessions, members of the team were encouraged to play in good quality local events. The team won the Knockout Teams. All three pairs also competed in the Alan Macarthur Teams with one pair in the winning team. Four members of the team competed in the Victor Champion Cup in Melbourne on the Queen's Birthday long weekend where they finished equal second in a high quality field. This highlights the importance of BFACT ensuring that the Tournament Calendar retains good quality teams' events in the immediate lead up to the ANC.

Only Margaret Bourke played in the Butler events in week one of the ANC and two of the pairs contested the Open pairs on the Sunday before the teams started. This meant the team was relatively "fresh" for the start of the teams.

## The Event itself - the Round Robins

The finish to the double Round Robin was the closest in a long time with five teams realistically in with a chance going into the final two matches. The ACT had finished the first RR in fourth place with 6 wins and only one loss to Queensland (by 18). In the second RR we remained close to the lead through to the last day when we had to play NSW and VIC in our final two matches. At this point I turned to my two more experienced pairs (Thomson/Brightling and De Livera/Bourke) to play these two matches and with the two resulting wins, we finished second when the music stopped.

# The Final against Victoria

The critical sessions in the Final were the two 10 board stanzas on the Friday night. I was able to bring in Hoffman and Wawn who were fresh from having not played the two earlier matches and they anchored a very good effort which saw us skip out to a lead of over 80 imps. There was some "tired" bridge from the Victorian players throughout the Final and while Victoria clawed some imps back in the last two sessions, the winning margin of over 40 imps was very impressive.

## Player Performances

All six players played exceptionally well and were extremely positive and cooperative throughout. On the comparative datum scores from the double RR, Bourke/De Livera were +105, Hoffman/Wawn +77 and Thomson/Brightling +51. These do not accurately reflect the relative performance of the three pairs because of my strategic decision not to play Thomson/Brightling in any of the four matches against the two "datum building" teams of NT and TAS. I judged that Thomson/Brightling would improve most as the event progressed only by playing the tough teams. This proved to be so because in the last two RR matches when I needed them to step up to the plate, they went +54 against NSW and VIC. I would like also to single out Arjuna De Livera who played very well in spite of the fact that his son Michael had been very sick prior to and during the event.

# The Role of the Non Playing Captain

Winners are grinners. There is a long running debate over whether we <u>need</u> to send NPCs to ANCs. Apart from contributing to team morale, the captain's main role is to take the tricky line up decisions in the final few matches and if you are lucky to be there, in the Final. The players are far too focussed on playing to be totally rational and objective in these pressure situations and if they fail, it is always convenient to have someone else to blame! Sending a non-playing captain is money well spent.

#### **Seniors Team Captain's Report**

The ACT Seniors Team consisted of Brian Thorp and Andrew Struik, Ross Crichton and Peter Grant, Elizabeth Havas and Gytis Danta.

The first two pairs had played in the Australian Butler Trials the week before the ANC with very good results, and Elizabeth has an outstanding record of achievement at State and international levels. Add to the fact that Ross and Peter are in the current Australian Seniors' team, it was not surprising that we were hopeful that we would be competitive (or better) against all teams. Unfortunately, luck tended to run a bit against us and the final position (5<sup>th</sup>) was not as good as we could reasonably have expected.

There were, however, a few highlights. We were the first team to record a win against SA (in round 12 of 14, at which stage SA were averaging 30 IMP wins against all comers) followed by a win against Victoria, the eventual winners; we also recorded a good win against WA at the end of the first round robin, just when we needed to get back into contention. The lowest point was a small loss to NT in match 1, which was about as bad a start as we could ever have imagined.

On the question of luck, I can think of at least 6 cases where a key card was offside, or a good contract foundered on a 5-1 break, or in an even-money choice we went one way and our opponents went the other (successful) way. Each of these cases represented a swing of 26 IMPS. No doubt some decisions went the other way, but are less well engraved on my memory!

The venue – the Dallas Brooks Centre in Melbourne – was handy for access to restaurants, but rather claustrophobic. I would have preferred a venue where the tables were further apart, with some natural lighting during the day.

The format of the event was acceptable, but if we had added the two head-to-head matches together as a single match we would have fared rather better. The 24board sessions were perhaps just a bit too long – either 20 boards, or with a short break after 12 boards would be more sympathetic to the Seniors.

At a personal level, I decided it would be counter-productive to watch our Seniors playing, so I usually watched the team we were to play against next. Towards the end of the week, I had the pleasure of watching some very good bridge by our Open Team.

Despite the disappointments, the feeling between the 3 partnerships was amicable and most of the post-match score-up discussion was apologetic rather than critical. Poor results tended to increase the determination to bounce back, but overall the team felt that it had not achieved the results it was capable of.

Finally, I wish to record my appreciation for the cheerful cooperation of all players, and in particular the generous contribution made by Elizabeth Havas, as team member, system advisor (when asked) and my sounding board on seating strategy for some matches.
