#### Percentages:

In a teams match when deciding whether or not to accept an invitation to game, the following calculation might be useful.

Assumption 1: The only possible results for the major-suit contract are 9 tricks or 10 tricks.

Assumption 2: Your opponents will never double.

Assumption 3: The players at the other table have bid a partscore in the same major.

#### Question:

Should you really call the TD after all (alleged) infractions?


#### Answer:

No. While Law 9 requires that the TD \*must\* be summoned after attention is drawn to an irregularity, Law 9 also states that any player \*may\* draw attention to an irregularity. That is, drawing attention to an irregularity is optional.

If an opponent technically infracts Law 75 by mis-explaining a bid, but the infraction does not damage my non-offending side, then I do not waste the TD's time by drawing attention to this innocuous irregularity.

While playing in the Women's Trials, a rather amusing incident occurred. In the middle of an auction, a certain BFACT News editor (hint - Alfred Hitchcock named a film after her) nearly knocked over her bidding box. In the act of rescuing it, I put my hand down on the table. When I had righted my bidding box I looked at my hand - face up on the table! I called the Director (who was Sean) and after explaining rather sheepishly what had happened, Sean was heard to say "I've been waiting 20 years for this!" The result? 13 penalty cards that all had to remain on the table during the auction and my long-suffering partner (Wendy Boxall) was barred from the auction.

The opposition ended up in 3NT with Wendy on lead. Declarer now had the juicy option of prohibiting a lead of one or more suits. Declarer prohibited a lead of a diamond or a spade and I got to pick those suits up, while the rest remained penalty cards. This meant that Declarer got to play her 13 cards, Dummy's 13 cards plus my 7 remaining penalty cards! Fortunately for me, the end result was that Declarer made twelve tricks in 3NT instead of ten and Wendy was VERY forgiving!

In more than one club, the above results will be of some surprise. The best result in the overall scoring for each club were usually not the same pair who scored best in each local club's normal duplicate score for that night. I checked the scores, it's just the way it goes. The winners' good scores were good in all clubs, not just at their club.

I had a complaint from one of the better scoring pairs that surely the commentary should say slam should be bid on the following board (EW in  $6 \Rightarrow$ ):

I believe I will defend the original commentator's opinion, although the objection is a reasonable one. There are two potential finesses here ( $\bigstar$ K,  $\bigstar$ A) that both apparently have to work for slam to come in. However, a diamond can be pitched on the  $\checkmark$ AK, which now brings the contract down to about a 50% chance based on the spade finesse. If West deliberately bids clubs first, 64 will be played from the correct hand, because two rounds of diamonds cannot be lost on the opening lead, even if the  $\bigstar$ A is in the North hand.

Ah, yes, I can hear the pedantic experts say: If you want to bid slams that are "about" 50% based on "only" one finesse, go right ahead. You'll come out worse than 50% in the long run, because very occasionally you'll get a freak ruff or badly breaking trumps as well. The above case is reasonably safe from this, but how does West know that spades do not break 7-0 in NS cards, and there's a ruff on the opening lead? Or a 7-1 break in diamonds with the first 2 tricks going  $\blacklozenge$  A, diamond ruff? Because neither North nor South pre-empted at their opening bids? Oh, if only I could rely on the opponents I play being always that predictable!

Instead, I poorly judged the auction, stupidly assumed that Bal's @ contract would make, and ridiculously took a phantom save in  $6 \bigstar x$ . At the table, Bal guessed to lead the  $\bullet$ 4. Unlucky! +1310 to the good guys for the overtrick. Upon the selection of the opening lead, an expression of mild disappointment crossed Hashmat' s face. I deem that Hashmat prefers me as a partner, rather than as an opponent.

#### **ACT ANC Representatives:**

The Australian National Championships (ANC) are being held 23 July to 7 August in Melbourne this year. The ANC is the event where each State and Territory has the opportunity to play each other to find out who is the best.

The Congress starts with the Butler Pairs. The Open and Women's Butler run at the same time. This event is run in three Stages. Stage I is open to everyone to play. Stage II is only open to people who qualify from Stage I plus one pair per State/Territory. Stage III is only open to those who qualify from Stage II and the winner is determined.
